### 3-703 DEPOSIT; WATER, SEWER AND GARBAGE SERVICE.

A) All applicants applying for water, sewer, and garbage service shall make a utility service deposit as a guarantee for the payment of all bills for water, sewer and garbage. Deposit Charges will be set by resolution of the Village Board and on file at the office of the Village Clerk. Such deposit shall be refunded to the customer when service is no longer being furnished or after one year if requested by resident, provided all water, sewer and garbage accounts have been in good standing without penalty and are paid in full.

**3-110 WATER BILLS**: Water bills shall be due and payable monthly. The Village Clerk is to charge and collect from each customer for the monthly fee for water usage, together with any other charges, properly itemized, due the water department. Bills shall be processed no later than the 5<sup>th</sup> of each month and shall be due on the 15<sup>th</sup> day of the same month as the billing. Bills paid after the 15<sup>th</sup> day of the month in which payment is due shall have a penalty charge added hereto the bill of the consumer. Penalty Charges will be set by resolution of the Village Board and on file at the office of the Village Clerk. Bills not paid by the 15<sup>th</sup> day of the month shall be deemed to be delinquent. Upon being deemed to be delinquent, as herein defined, the Village Clerk shall follow the procedures outlined in Section 3-701 regarding disconnections of utilities. The Village Clerk shall assess an additional fee set by resolution of the Village Board and on file at the office of the Village Clerk in the event that the water is shut off for the non-payment of any water bill, to compensate the Village for the additional hook-up necessary to again provide water service to the delinquent customer.

## A RESOLUTION TO SET THE UTILITY DEPOSIT; WATER, SEWER AND GARBAGE SERVICE- FOR RESIDENTIAL AND COMMERCIAL ACCOUNTS.

**WHEREAS**, the Village of Kenesaw, Adams County, Nebraska, has the authority to set the Utility Deposit for Water, Sewer, and Garbage service by resolution (ORD NO. 525-2019),

**WHEREAS**, it is the best interest of the Village of Kenesaw, Kenesaw, Nebraska, Adams County, that a Utility Deposit for Water, Sewer and Garbage services be set in order to cover the costs incurred by the Village.

**NOW THEREFORE, BE IT RESOLVED** by the Village of Kenesaw, Adams County, Nebraska, that a Utility Deposit for Water, Sewer, and Garbage services be set at \$ 185.00 (one hundred eighty-five dollars) to be paid as outlined in Ordinance 525-2019. This rate is hereby adopted commencing on February 12, 2019. This Resolution supersedes any and all previous resolutions with regard to Utility Deposit Rates.

## A RESOLUTION TO SET THE UTILITY LATE PAYMENT PENALTY CHARGE FOR RESIDENTIAL AND COMMERCIAL ACCOUNTS.

**WHEREAS,** the Village of Kenesaw, Adams County, Nebraska, has the authority to set late payment penalty charges by resolution (ORD NO. 524-2019),

**WHEREAS,** it is the best interest of the Village of Kenesaw, Kenesaw, Nebraska, Adams County, that a utility payment late fee be established to promote timely monthly utility payments in order to cover the costs incurred by the Village.

**NOW THEREFORE, BE IT RESOLVED** by the Village of Kenesaw, Adams County, Nebraska, that a Utility Late Payment Charge of \$10.00 (ten dollars) be assessed monthly to all utility accounts on which payment has not been made as outlined in Ordinance 524-2019. This rate is hereby adopted commencing on February 12, 2019. This Resolution supersedes any and all previous resolutions with regard to Utility Late Payment Penalty Charges. **PASSED AND ADOPTED** this **12th** Day of **February, 2019.**
